Whereas, never before has a nation been as successful, peaceful, and prosperous as America since 1776.

Whereas, never before has a nation done more for the cause of global peace, prosperity, and liberty.

Whereas, those successes globally are directly attributable to the liberty of citizens of America.

Whereas, America quickly became the beacon to the world of how nations should be governed and how the natural state of people is to be free.

Whereas, the founders of this great nation were men and women willing to sacrifice all that they had, including their own lives if required, to establish that cause of peace.

Whereas, the words, "In God We Trust" are taken seriously here.


Whereas, patriots of America are needed in every county, city, town, and household.


Whereas, all institutions of education, public and private, must demonstrate a dedication to teaching the principles of Americanism.




