Voter Information Public Service Request

Lists contain only voters residing in Washington County. If your district crosses county lines, please submit a request through the Lt. Governor's office to receive a list will all voters.

The cost of the voter information is a \$25.00 setup fee and \$0.005 (1/2) cent per name.

Effective January 1, 2024 credit/debit transactions must pay an additional 2.5% fee with a \$1.50 minimum.

Requests may be submitted via mail or in person to the Clerk-Auditor office. They may also be received via email to elections@washco.utah.gov.

Once a request is received, the Election office will calculate the fee and call the requestor to obtain payment information. Requests will be completed within 5 – 7 business days. Responses will be sent via email as an encrypted .xlsx file.

By signing below, I swear/affirm that the information I provided above was true and correct to the best of my knowledge. I further understand and attest to the following:

- I understand that private voter data is a different classification than withheld voter data and that withheld voter data will not be included in my voter file (20A-2-104).
- I understand that I am a qualified individual under 20A-2-104 to request and possess this information.
- I understand that I will only use this information for political purposes and in accordance with state law and will not disclose any information received to parties that are not qualified under 20A-2-104.
- I understand that making false statements in this document is punishable by law under UCA 76-8-504.
- I understand that an individual who obtains a voter registration record under false pretenses or provides or uses voter registration information that is obtained from the list of registered voters in a manner prohibited by law, is guilty of a Class A misdemeanor.
- I understand that an individual who obtains voters year of birth under false pretenses or provides or uses voters' year of birth that is obtained from the list of registered voters in a manner prohibited by law, is guilty of a class A misdemeanor and is subject to a civil fine.
