*Pursuant to §41-12a-303.2, Utah Code Ann., please be aware that each of these violations are mandatory **UNLESS** you were insured at the time the ticket was written. **If so, the charge is dismissable.** In order to have the charge dismissed, you **must** do the following **within 28 days** from receiving the ticket: Obtain a letter from your insurance agent **dated the day you are receiving the letter**, stating two items: 1) that the vehicle and you were insured prior to the day the ticket was written and 2) that there have been no lapses in policy coverage. This information may be faxed to the Court at (435) 656-3003 as long as it contains the defendant's name and citation or case number on it. Please verify with the Court that the proof of coverage letter was received by us. If you fail to do so, you may incur extra costs due to failing to appear. You may also present the proof at the Justice Court payment window.

*Expired or No Registration: If you register the vehicle and show proof to the Court, \$10 will be suspended upon compliance. Submit proof to the Court in order to obtain the \$10 suspension of the bail.

**New resident fail to register: If you are residing in Utah and register the vehicle, \$800 will be suspended upon compliance. Submit proof to the Court in order to obtain the \$800 suspension of the bail.

***No safety inspection: If you obtain a safety inspection, \$10 will be suspended upon compliance. Submit proof to the Court in order to obtain the \$10 suspension of the bail.
